3. Reports
 - a. VCTC Bus
 - i. Activated DolphineOne cards as of 4/24; Students: 450; Staff: 16; Faculty: 5
 - ii. There were 48,972 rides on Routes 90-99 lines last year, out of those rides, 23,977 were CSUCI Riders, 24,995 were non-CSUCI riders
 - iii. Since half of the riders are non-CSUCI students, staff, faculty then why is CI (parking) paying the local match? Parking is paying 100% of that bill, we need to find an alternative source to pay for the bus
 - b. Zipcar as of 4/24
 - i. Total CI Accounts: 168 Users, back to 2 Zipcars on campus, 1 in Town Center, 1 in parking lot A5
 - ii. March: 101 Reservations made by 31 members, putting 4,008 miles on Zipcar, 326.5 hrs.
 - iii. Feb.: 97 Reservations made by 31 members, putting 3,270 miles on Zipcar, 233 hrs.
 - iv. Jan.: 64 Reservations made by 17 members, putting 2,312 on Zipcar, 204.5 hrs.
 - c. Fall '23 – Spring '24 Low Emission Vehicles
 - i. Fall: 26 students applied, 7 student's cars were not L.E.V. approved; Spring: 38 students applied, 2 housing staff, all were approved
 - d. Carpool permits sold as of 4/24
 - i. Fall '23: 45 permits; Spring '24: 44 permits
 - ii. Some suggest that the carpool stalls need to be reduced because they seem empty
 - iii. Our goal is to reduce the amount of vehicle driving to campus and reduce regional vehicles miles traveled
 - e. Metrolink's Sustainable Fashion Show
 - i. Metrolink decided to do a something new for Earth Day and throw a Sustainable Fashion Show competition to turn the runway green with eco-friendly creations. They wanted to encourage students from the 6 counties Metrolink services to enter the competition to submit a sustainable fashion design created from recycled textiles or materials and then the top designer would be invited to show case their designs. We had two CSUCI students be top contenders, Giselle Navarro and Valerie Flores.
 - f. EV Charger update
 - i. SCE let Roxane know that the 30 EV Chargers going into the A8 parking lot should be energized in late August



- ii. We need to inform the community at large before coming back in the fall about the A8 parking lot/chargers being installed
